## Notice of Decision for a Director's Modification

Osgood Property - DIRM2014-00190

**Project Description:** The applicant requests modification of those standards to allow, subject to all other applicable provisions of the Sammamish Municipal Code, a subdivision of the property located at 19661 SE 24th Way, Sammamish. The subject site is located within the erosion hazard near water body overlay and in the no disturbance area that normally prohibits subdivision. The proposed modification would allow for subdivision of the property provided water quality was improved post development. The applicant is proposing to install a drainage pipe down SE 24th Way to the bottom of the hill and shall incorporate level 3 flow control along with other water quality improvements.

The applicant (Jim Osgood and Susan Richardson) applied for the above project on August 20, 2014; following a review to confirm that a complete application had been received, the City issued a letter of completion to the applicant on September 10, 2014. On September 18, 2014, the City issued a Notice of Application / SEPA Notification, which identified a public comment period from **September 18, 2014** through **October 9, 2014**. The City of Sammamish issued a decision on February 17, 2015. This Notice of Decision was issued on **February 17, 2015** and public notice has been provided via: mailed notice to property owners within 500 feet of the subject site, a sign posted on the subject site, and by placing a legal notice in the local newspaper. The application has been **Approved with Conditions**.
