REVISED NOTICE OF APPLICATION / SEPA NOTIFICATION 223RD ASSEMBLAGE - PSUB2014-00087

Project Description: The applicant proposes to subdivide approximately 12.76 acres including four parcels into 38 single family residential lots. The existing three homes are proposed to be demolished. The site is located in the erosion hazard near sensitive water body overlay and is constrained by a category I wetland. Offsite improvements to 223rd Ave SE are anticipated.

Revised notice is provided to reflect the request by the applicant to modify property specific drainage requirements from the Erosion Hazard Near Sensitive Water Body overlay, pursuant to SMC 21A.50.225(2)(c). In particular, the applicant has requested that open space be located around the perimeter of the project to retain additional trees.

On April 28, 2014 an application was submitted by 1402 WLD 223 ASSEMBLAGE, LLC (Rep. Kerek Edwards) and deemed complete on April 30, 2014. On May 08, 2014, the City issued this Notice of Application/SEPA Notification by the following means: mailed notice to property owners within 500 feet of the subject site, a sign posted on the subject site. and by placing a legal notice in the local newspaper.
