**NOTICE IS HEREBY GIVEN** that on April 28, 2017 the City of Sammamish Department of Community Development issued a decision for the Singh Short Subdivision, PSHP2015-00235.

The Plattor proposes to divide a 2.5-acre parcel into four lots for single-family residential development. The property is zoned R-6. The subject site is currently developed with one single family home, which is proposed to be demolished as part of the development. There are critical areas present on the property.
