## Determination of Non-Significance (DNS) 223<sup>rd</sup> Assemblage Subdivision PSUB2014-00087

## Description of proposal:

The applicant is proposing to subdivide approximately 12.77 acres of property located at the intersection of 223<sup>rd</sup> Avenue SE and SE 38<sup>th</sup> Street into 40 lots. The property is located at south end of 223<sup>rd</sup> Avenue SE. 4 parcels are involved in the project, including tax parcels 092406-9108. 9116, 9165,and 9196. The storm drainage will be directed to a detention vault, a sand filter and then a dispersion trench. The proposed plat will include a road connection to the 223<sup>rd</sup> Avenue SE.
