Notice of Threshold Determination and Short Plat Decision

Stewart-Porter 8-lot Short Plat - PSHP2014-00018

Project Description: The applicant is proposing to subdivide two parcels consisting of 2.35 acres zoned R-4 into eight lots for single-family residential development. The subject site is currently developed with two single-family homes, which are proposed to be demolished as part of the development. There are no critical areas present on the property.

The applicant (PNW Holdings, LLC) applied for the above project on January 22, 2014; following a review to confirm that a complete application had been received, the City issued a letter of completion to the applicant on January 22, 2014. On January 28, 2014, the City issued a Notice of Application / SEPA Notification, which identified a public comment period from January 28, 2014 through February 18, 2014. A DNS was issued on June 16, 2014. This Notice of Decision was issued on **June 16, 2014** and public notice has been provided via: mailed notice to property owners within 500 feet of the subject site, a sign posted on the subject site, and by placing a legal notice in the local newspaper. The application has been given **Preliminary Approval**.
